Annex to Agreement on the provision of services for registration of domain names

Put into effect on November 7, 2017.

TERMS OF RENDERING SERVICES № 2 for registration of the expiring domain name

1. General provisions

1.1. The present terms define the conditions and procedure for the provision of services related to the registration of expiring domain names and are an integral part of the Agree on rendering of services on domain name registration.

1.2. General definitions

Contractor – the limited liability company «SaleNames».

Customer – individual or legal entity approaching the Contractor for service for registration of an expiring domain name in the domain .RU or .PФ.

Expiration of a domain name (registration cancellation) — removal from Registry information about the domain name and its Administrator.

Order (Application) — a request from the Customer to the Contractor in the format established by the Contractor containing all necessary data for the expiring domain in domains .RU and .PФ.

Registration of the expiring domain name — the service provided by the Contractor to the Customer, also referred to as "service", consisting in the direction in the Registry of application for registration of the second-level domain name in domains .RU and .PФ after its expiration and entry in the Registry by the Registrar on the basis of the Customer's request information about the domain name, its administrator and other information set forth in the Rules of registration of domain names in domains .RU and .PФ, approved by ANO « Coordination Center for TLD RU » (further « The Terms of domain names registration in domains .RU and .PФ).

Tariff — the cost of service determined in accordance with the Tariff's validity period. Rates and their validity periods are specified in Annex No. 2 to the Agreement on rendering services on domain names registration.

Validity period - the time interval during which the cost of the service is not changed.

Note: definitions not specified in these Terms are defined in the document «Terms of rendering services No. 1/1 for registration of the domain names .RU, .PФ and .SU».

1.3. Registration of the expiring domain name is produced in accordance with the Agreement, these Terms, Regulatory documents and established by the Registrar and the order of registration actions published on the website of the Registrar (Registrar's instructions).

1.4. Registrar's instructions – manual published on the website of the Registrar (descriptions, requirements, etc.), establishing the order of registration, submission, review, payment requests of the customer, as well as other conditions for the performance of actions stipulated by the Regulatory documents. Registrar's instructions are binding.

1.5. In case of a conflict between the provisions of these Terms and regulations in the Regulatory documents, the latter take precedence over the terms of the Agreement and Terms.

1.6. By order of service for registration of an expiring domain name the Customer agrees to these Terms and to pay for the service according to selected in the Order Tariff.

1.7. The service for registration of the expiring domain name is deemed provided from the moment of entering a record in the Registry about domain name registration on the Customer's name.

1.8. On the fact of rendering services the Contractor shall notify the Customer by e-mail to the contact email address of the Customer. If reasoned objections from the Customer, set forth in writing and sent by post, did not reach the Contractor within 15 (fifteen) calendar days from the date of submission by the Contractor of the above emails, the service provided to the Customer by the Contractor is accepted by the Customer.

1.9. From the moment of entry in the Registry the record about domain name registration on the name of the Customer, the Customer is subject to the provisions of the Terms of rendering services No. 1/1 to the Agreement on rendering of services for registration of domain names.

1.10. The Contractor shall not guarantee to the Customer services delivery in the following cases:

- a) if by the domain name registration in the Registry the request of Contractor was not the first one among the applications submitted by other Registrars;
- б) if the registration period of the expiring domain name was extended by its administrator;
- в) if the domain name is the subject of court proceedings, subject to the availability of relevant evidence by the Contractor testifying to this;
- г) if domain name registration is canceled by an enforceable decision of a court when the pre-emptive right to register the cancelled domain name has the person whose rights the court found violated;
- д) в иных случаях, могущих повлечь, по мнению Исполнителя, нарушение прав третьих лиц;
- е) if the registration of the domain name contradicts to the Terms of domain names registration in domains .RU and .РФ;

ж) in other cases, which may prevent the registration of the domain name at the request of the Customer.

Upon the occurrence of specified events, the service will not be rendered, thereby the funds blocked in the personal account of the Customer on payment will be released and can be used to pay for other services.

2. The procedure and conditions of expiring domain name registration

2.1. Registration of the expiring domain name is carried out by the Contractor at the request of the Customer, which has fulfilled all the conditions of the Agreement, the present Terms and Regulatory documents, in case of payment by the Customer the full cost in accordance with approved tariffs.

2.2. In accordance with clause 3.3.3. of Terms of domain name registration in domains .RU and .РФ the service fee is established differentially depending on the period remaining until the beginning of domain name removal from the Registry and corresponds the current Tariff.

2.3. Conditions of order placement.

2.3.1. The order can be made 30 (thirty) calendar days before the estimated date of expiration of the domain and to 17:00 (Moscow time) on the day of the procedure of domain removal from the Registry.

2.3.2. Before the start of validity period «Tariff 950K» order can be placed:

- a) at any Tariff in the absence of another Order;
- б) at a Tariff with an earlier validity period – by having another order.

The validity period of the Tariff considered earlier, if from it to the start of domain name removal from the Registry left more time than from another Period. Validity period "Tariff 950K" is primal.

2.3.3. During the validity period of one of the Tariffs Order can be made:

- a) in the absence of other Order for current Tariff or the Tariffs with more recent validity period;
- б) by having another Order — at a Tariff with an earlier validity period but not earlier than the validity period beginning of the current Tariff.

2.4. The order will be cancelled by the Contractor, if:

2.4.1. The Contractor accepted the order of another Customer with an earlier validity period, all orders with a later validity period will be void. If funds are blocked, they are exempt from blocking on Customer's personal account and can be returned to the Customer on the basis of an official letter with specification of recipient's details or used to pay for other the Contractor's services.

2.4.2. The period of registration of the expiring domain name was extended by its Administrator. If funds are blocked, they are exempt from blocking on Customer's personal account and can be returned to the Customer on the basis of an official letter with specification of recipient's details or used to pay for other the Contractor's services.

2.5. Order processing starts after the domain name removal from the Registry. In case of successful completion by the Contractor the procedure of domain name registration, the Contractor enters information about the Administrator into the domain name Registry.

2.6. The Contractor's decision to register a domain name or to refuse the registration on the grounds stipulated by the present Terms, the Terms of domain names registration in domains .RU and .РФ, Terms of rendering services 1/1.
